Location

The property is situated close to the centre of Ribchester a small town in the Ribble Valley.

The nearest motorway access is via junction 6 of the M65 motorway which lies approximately 7 miles from the property.

Description

Bee Mill Industrial units comprise a former cotton textile mill which was converted and sub-divided into a series of small workshop/warehouse units approximately 30 years ago and currently offer a range of accommodation from 133 sq.ft up to 10,000 sq.ft

Each unit has its own w.c facilities, sub metered electricity and loading door.


